Rules of C.A.T.S. Dance Studio 49

1. Payment is due upon registration and spots cannot be reserved without payment and a completed registration form.
2. Three personal make-ups are allowed per semester in addition to holiday make-ups.
3. **TRIAL CLASSES:** All trial classes are \$30 and must be registered and paid for before the child enters the class. The child must be age appropriate for the class.
4. **REFUND POLICY:** The \$50 registration fee is non-refundable for all classes. After registering, there are no refunds; only credits less the registration fee and classes attended will be given. Credits given to dance students are only accepted in the dance department. After the first two weeks of the semester, there are no credits given.
5. **STUDIO ETIQUETTE:** Parents will be allowed in the classroom for Parent's Week and Creative Movement classes only. Video cameras and cameras should only be used during parent visitation week. Out of respect for the teacher and students, we encourage ALL parents and caregivers to have a seat in the lobby while class is in session. It is a distraction to the teacher and students when parents/ caregivers stand in the doorway and/or communicate with the children in class. Although the children are young (and so much fun to watch), we strive to maintain a level of professionalism. This is why we do have a Parent Visitation Week where you will be invited to come inside and see your child's progress and what they are learning in the class.
6. All students must be supervised before and after their class. Please notify the teacher if someone new will be picking up your child.
7. All children must have appropriate attire for class, as listed in the brochure.
NO JEWELRY, CROWNS, COSTUMES, GUM, FOOD or BEVERAGES are allowed in the studio. Please keep skirts simple. Please keep hair neat and off the face.
8. Children should not attend class if they are ill. Teachers may ask students exhibiting symptoms to leave class.
9. Please encourage your child to have water and use the restroom before class begins.

MOTHER & CHILD CLASSES:

- Each child must be accompanied by one parent/caregiver.
- Please note that your role in the class is to assist your child in movements and encourage him/her to focus on the teacher!
- Please keep voices low so the children can hear the teacher.
- Siblings are not allowed to participate in the class.
- Cameras are only to be used on the week of parent visitation.
